

NYS Board of Elections Proposal Election Returns Nov. 5, 2013

Proposal Number Five, An Amendment

In Relation to a Land Exchange in the State Forest Preserve with NYCO Minerals, Inc. The proposed amendment to section 1 of article 14 of the Constitution would authorize the Legislature to convey forest preserve land located in the town of Lewis, Essex County, to NYCO Minerals, a private company that plans on expanding an existing mine that adjoins the forest preserve land. In exchange, NYCO Minerals would give the State at least the same amount of land of at least the same value, with a minimum assessed value of \$1 million, to be added to the forest preserve. When NYCO Minerals finishes mining, it would restore the condition of the land and return it to the forest preserve.

Shall the proposed amendment be approved?
